

Privacy Notice

The organizing committee of Ministry of Agriculture, Forestry and Fisheries (MAFF) issues this Privacy Notice to inform you of our collection, access, use and process your personal data in the way described below.

1. Categories of personal data

We hereby inform you that we collect, use and process the following categories of your personal data:

- Name
- Nationality
- Sex
- Date of Birth
- Workplace Information
- Home Address
- Email Address
- Phone Number
- Social Media Account ID
- Profile Photo

2. Legal basis and purpose (As per Article 6(1)(f) GDPR, we hereby inform you that we use your personal data for the purpose of providing you the following services.)

- To operate and manage the Washoku World Challenge and website.
- To contact you regarding the registration procedure and selection result.
- To provide information related to this contest.
- To post registry information/challenge details/selection results on this website, SNS, the Ministry of Agriculture, Forestry and Fisheries home page as well as publishing in various other media outlets.
- To distribute the participant's list to the Contest delegates.
- To contact you for any other reasons that arise.

In addition, your personal data may be converted into statistical or aggregated data which cannot be used to identify you and then used to produce statistical research and reports.

For purposes other than those stated above, Washoku World Challenge will not use your personal information.

3. Retention periods

We keep your personal data as long as there is a statutory or legal requirement to do so or in order to provide the aforementioned services to you. For accounting or auditing purposes we may retain your personal data for a period of time after our direct business dealings have ended.

4. Data storage and transfer

Furthermore, we may share your personal data with other companies which may be located within or outside the EEA and provide business process services related to the provision of the services indicated above. Where a company is located outside the EEA, we will arrange adequate safeguards such as Binding Corporate Rules or Standard Contract Clause arrangement or transfer your personal data based on appropriate legal basis.

5. Prior consent

Where we require access to your Personal Data considered sensitive by GDPR, we will seek separate explicit consent from you prior to obtaining that data.

6. Your rights
